Detailed scope

Einkauf von Rundholz und Sägenebenprodukten (FSC 100%, FSC Mix, FSC Controlled Wood, kontrolliertes Holz), ausgelagerte Holzernte, Herstellung und Verkauf von FSC Mix Faserplatten mit dem Prozentsatzsystem. Einkauf von FSC Mix und FSC Controlled Wood Faserplatten und Spezialpapieren, Herstellung, Outsourcing (Lager) und Verkauf von FSC Mix zertifiziertem Laminat-Fußboden mit dem Kreditsystem. Handel mit FSC Mix und FSC Controlled Wood Dekorpapieren und Faserplatten mit dem Transfersystem.

Purchase of round wood and sawmilling co-products (FSC 100%, FSC Mix, FSC Controlled Wood, and controlled wood), outsourced harvesting, manufacture and sale of FSC Mix fibre boards, based on the percentage system. Purchase of FSC Mix and FSC Controlled Wood fibre boards and specialty papers, manufacture, outsourcing (warehouse) and sale of coated FSC Mix certified laminate flooring using the credit system. Trading FSC Mix, FSC Controlled Wood decor papers and fibre boards using the transfer system.
